- 1. Age limit: The minimum age limit is 18 year and the maximum age limit is 30 years as on closing date (Relaxable by 05 years for SC/ST & 03 years for OBC (Non Creamy layer) & 10 years for 40 % PWD candidates (VH/OH/HH) in their category.
- 2. Stipend: As per provisions of Apprentice Act 1961
- 3. Training Duration: One Year.
